

# A quick guide to the ideas in the LB Bill





A Bill is an idea about changing the law.

The LBBill is an idea to change the law for disabled people so that they have more control over what happens in their lives.

The LBBill has 10 main ideas. The ideas are called clauses. 2

#### Clause 1

Councils and the National Health Service (NHS) must do what it says in Article 19 of the Convention on the Rights of Persons with Disabilities (CRPD).

This clause is based on Article 19 of the CRPD. It says that the government needs to make sure that disabled people can;

 Have the same rights as other people to choose how they live



 live where they want to live

 get the help they need to live in their communities, work, have education and a social life

 Not be forced to live where they don't want to live, unless the law says they should




### Clause 2

When deciding about paying for care at home for disabled people, the focus should be about what people need.

 Decisions about paying for care should be fair

 Councils and the NHS should pay for the care that helps disabled people to stay in their communities like it says in Article 19 of the CRDP



### Clause 3

Councils and the NHS must have enough support for disabled people in the community.

 Councils and the NHS need to plan services that help people stay in their communities



### Clause 4

Every disabled person should get support and live in the place that best suits them.

If disabled people need to live somewhere they don't choose to because the law says;

- They must live in a place that best suits them; and
- Plans should be made to help people move to the right place for them as soon as possible

### Clause 5

Whenever a disabled person moves or is moved from where they live, this should be approved.



 Decisions about moving need to be made by disabled people where possible

 If it is not possible for the disabled person to make the decision, the Council and NHS need to make sure they involve the right people and organisations to make decisions



### Clause 6

Councils and the NHS should have to be open about the disabled people they support at home and in care homes or hospitals.

 Councils and the NHS have to tell the public about how they help or don't help disabled people to live in their communities

#### Clause 7

The Mental Capacity Act 2005 should change to give better rights to disabled people and families.

 The Mental Capacity Act should be stronger to make sure that disabled people can choose where and how they live and their families can have a say



### Clause 8

People with learning disabilities and autism shouldn't be under the Mental Health Act 1983.



 The Mental Health Act should not be used for people with learning disabilities and autism when they do not have a mental illness, unless the alternative is that they would go to prison



### Clause 9

Councils and NHS must provide community mental health services to disabled people.



 Mental Health Services should be provided in communities to support people with learning disabilities and autism, like it is with everyone else




### Clause 10

Councils and the NHS must involve disabled people and their supporters in decisions about their care.



- Councils and the NHS should help disabled people make decisions properly by:
  - including the right people to help,


